

# Professionalism

As a Member of Unlimited Network, I hereby agree that:

1. I will be honest and fair in all my dealings while acting as a Member of Unlimited Network.
2. I will respect the time and privacy of the people I contact to become workshop participants and Members of Unlimited Network. I will be courteous and respectful to every person I contact in the course of my Unlimited Network business. *I will value people more than business and make friendship a priority over my desire to have people participate in Unlimited Network or Unlimited Network sponsored modalities.* I recognize that the founders of Unlimited Network have strong personal convictions regarding this aspect of ethical conduct of all of Unlimited Network's Members.
3. I will perform all my activities in a manner which will enhance my reputation and the reputation of Unlimited Network.
4. I will not engage in any deceptive or illegal activities.
5. As a Member I will not make claims for Unlimited Network sponsored workshops, services, or products except as contained in official company literature. I also understand and agree to the responsibilities of "commercial speech." Claims made in the promotion of commercial goods and services exceeding the requirements of either scientific research, or other forms of "free speech".
6. As a Member I will not make income claims or representations, or income projections, including those based solely on mathematical projections or "ideal projections" of Unlimited Network's Compensation Plan. Any such statements of ideal projections of Unlimited Network's Compensation Plan are unrealistic. No Support System grows in a perfect geometric progression, and it is therefore impossible to predict incomes. Further, an Unlimited Network Member's success depends on many variables, such as amount of time and effort committed to his/her business and individual organizational ability.
7. As a Member I agree to represent the Unlimited Network Compensation Plan fairly and completely. I will make no claims regarding potential income, or earnings other than as explained in official company literature. Thus, I will not represent my own income as an indication of others success.
8. As a Member I will emphasize that retail sales are a requirement for making a profit and that it is illegal to receive a fee for sponsoring other people into a network marketing company.
9. I understand and agree that I am solely responsible for all financial and/or legal obligations incurred by me in the course of my business as an Independent Member of Unlimited Network. Each Member is an independent contractor and owns their business. Therefore, as a Member I am fully responsible for my business and any and all expenses acquired in conducting my business as an Independent Member of Unlimited Network. This includes (but is not limited to) workshops, services and products, travel expenses, office expenses, telephone, and self-employment taxes, income taxes, license fees, etc.
10. I understand that I am responsible for any business responsibility that I acquire in conducting my business as an Independent Member .
11. As a Member I understand and agree that when I receive an order of an Unlimited Network sponsored workshop or other product, I will proceed within three days to deliver this to Unlimited Network's Office. I understand that this money belongs to the ordering person and deserves prompt delivery for processing and registration.

12. I understand and agree that I am solely responsible for my success as an Unlimited Network Member. I know that my success with Unlimited Network and Unlimited Network sponsored modalities may depend on how much time I spend with my business. I know, being my own boss, I am in charge of choosing how much time I spend with my business, and what those times are.
13. I recognize that when I or another Member brings or sends a person to an Unlimited Network event or workshop or an Unlimited Network related activity or gathering, we have a right to absolute confidence that the prospect will be safe from cross-recruiting and inspired to participate in other than Unlimited Network event or workshop, for the duration of the specific Unlimited Network event. The duration of such an event is considered to extend until such time that a prospect leaves the specific activity and returns to their normal activities unrelated to Unlimited Network.

I will respect other professionals who are affiliated with Unlimited Network. Members, whether in the same Support System or not, will support the sponsoring efforts of other Members. I will not actively recruit a prospective Member, client or workshop participant (hereinafter "Prospect") for my own purposes at a time when that prospect is in the company of another Member, or who has been sent or brought to any event by another Member or with the intention to Sponsor that individual as an Unlimited Network Member, client or participant of an Unlimited Sponsored workshop. I agree to abide by this practice regardless of whether or not I had previous knowledge or acquaintance with the Prospect. It is my responsibility as an Unlimited Network Member when meeting an individual at, or surrounding, an Unlimited Network related activity, to determine whether or not a Prospect was invited by another Member. If it is unclear, whether or not the Prospect has been invited by another Member, I need to explicitly make clear that there can be personal benefits for the person that has invited them and ask whether such a person exists or not.

If more than one person has invited a Prospect and/or been involved in the process of inspiring the Prospect, the Prospect may choose who they like to be sponsored by or if the Prospect agrees, the inspiring Members may create a business that they can get a tax identification number for and apply to become an Unlimited Network sponsored Member as a business with that business' tax identification number and sign up the Prospect under that business.

If a Prospect has already participated in an Unlimited Network sponsored workshop they are advised, but not obligated, to continue getting sponsored by their original Member. No one is obligated to use a certain Member until they have signed up as a Member.

14. Occasionally, one or more individuals may contact the same prospect, resulting in a dispute over sponsoring and supporting rights. Unlimited Network will not mediate in such disputes and will recognize as sponsor the person whose name appears on the Application Form. In the event that two or more applications are received, the one received first by Unlimited Network will be recognized.

If two or more Members wish to share the benefits of a new participant, they can sponsor this participant together, if they:

- A. File a new Member's Application and Agreement Form as a partnership with the business name, its business Federal Tax I.D., the business address, telephone number, including the payment for the Member's Kit and will treat this Support System according to the Unlimited Network Policies. The new business application cannot be in the same Support Line of either of the Members filing the application. Instead it must be under the sponsor of one of the Members.

- B. File a new Member's Application for the participant that is received by Unlimited Network's Office within the same calendar month of the date of the first Member's Application with the signatures of all parties involved.
15. An Unlimited Network Member that wishes to recruit a person into another networking company other than Unlimited Network and knows that the prospect is an Unlimited Network Member needs to suggest to the prospect to sign-up under their Unlimited Network Sponsor. It is the prospect's right to choose whether or not he/she wishes to sign-up under his/her Unlimited Network Sponsor. If the prospect chooses to sign-up under his/her Unlimited Network Sponsor and this Sponsor is not a Member of this other network marketing company, the recruiting Member shall call the prospect's Unlimited Network Sponsor and inform him/her what the prospect's intentions are and give this Sponsor the option to join and have the prospect as his/her down line. If the Sponsor does not want to join the prospect can be signed-up. If the prospect chooses to not sign-up under his/her Unlimited Network Sponsor the recruiting Member can sign the prospect up, as well as, calling the prospect's Unlimited Network Sponsor and inform him/her about the situation.
16. I understand and agree that it is my responsibility as a sponsoring Member to educate new Members about how the business of Support System works, so they clearly understand the sponsoring and supporting relationship and can thereby act appropriately and respectfully in a sponsoring and supporting situation.
17. I will respect the professionals of other Network Marketing companies. I will not solicit from the proprietary rolls or "genealogical" printouts of other Network Marketing companies. I will not use sales materials or professional associations that may be regarded as proprietary by other companies. Unlimited Network seeks to promote the reputation of all reputable Network Marketing companies and Support Lines.
18. Networking and cooperation among Members leads to the success for a concerned. This is also true for Members in different Support System. Networking with other Members can result in many benefits such as: The cost of workshop, meetings and advertising being divided among Members.
19. Communicating with Unlimited Network or any other parties should preferably be person to person. Leaving messages is not a clear or guaranteed way to ensure that a message has been received or understood.
20. Unlimited Network Members are discouraged from gossiping because gossip always creates separation between people.

Larger and more productive meetings can be arranged, resulting in additional enthusiasm, excitement and success.

Gossip is relating negative information about a person that is not present, with the intention of receiving special attention.

Gossip is information given to a third party that is not communicated to the person in question and thus one is going behind somebody's back. It is not gossiping to explain the facts of a situation that has been communicated with the persons Involved.

Choose to not discuss negative information about people that are not present and thus loose time and creativity for something good. Choose not to gossip and see the good side of people to feel good and to be respected by people.

If an Unlimited Network Member hears negative talk about people that are absent, the Member is advised to encourage the gossipier to communicate directly with the person(s) talked about.

Once a gossip is heard even if you don't believe the gossip you hear, a small seed of suspicion is always planted in the mind of the person listening to gossip. To clear this, contact the person being gossiped about and ask if the gossip is true. This is so you can have an open relationship with this person later and also for this person to heal why they create being gossiped about.

This may benefit the person gossiped about. Getting to hear what is said about them, they receive information about what kind of rumors they create about themselves and can take appropriate actions to clear themselves.

21. Unlimited Network Members and anyone involved with Unlimited Network, or its products and services, are encouraged to share all their doubts and discontentment, directly with the people they have discontentment with. It is important to have clear personal and business relationships, to be able to support others in our business, and to grow and learn.

If a communication can't be satisfactorily completed by all involved, the person(s) involved are encouraged to write to Unlimited Network's Steering Committee, which will set up a meeting for a clarification.

If the complaint can't be resolved, and continues to be harmful to people and Unlimited Network, the Steering Committee has the power to terminate the Member's participation for not adhering to the Policies of Unlimited Network.
